



## LUCY CUTHBERTSON MEMORIAL FUND

In February 2005, Lucy Faith Cuthbertson, at the age of 24, died of meningitis in London, England. In memory of their beloved daughter and sister, Brian, Lindsay and Richard have established, in association with the Halifax Junior Bengal Lancers, the Lucy Cuthbertson Memorial Fund. As a young girl, Lucy joined her older brother as a rider with the Lancers. Her love of horses and riding meant that she literally grew up at Lancers, becoming a qualified instructor for young riders. As well as riding Lucy played basketball for St. Patrick's High School and for the University of King's College. While completing her Masters in Economics at McGill University, she was a stalwart member of a Triathlon Club.

The Cuthbertson Family and the Lancers have signed an Agreement that the annual income from the Fund will be used each year to send selected children to a riding camp at Lancers. These camps will teach the fundamentals of riding and encourage the participants to take an active role in the care of horses and to develop a strong sense of responsibility and self-respect.

The Nova Scotia Amateur Sport Fund has approved the Fund and its purposes, enabling contributions to qualify as charitable donations under the Income Tax Act.
